"Could you be a Trustee?"

You may be able to support a Charity or a voluntary sector organisation by volunteering to join their board or committee. But if you don't know much about the sector, how charities work or the role of a Trustee, then how can you make an informed choice? This session gives you all the background you need to know. So if you're new to the sector but want to find out more about Trusteeship, come along.

"Finances for non-financial Trustees"

Organisational finances should not be left entirely to your Treasurer. Every trustee should have at least some understanding of the financial reports they are presented with. So this session is for trustees wanting to understand the basics of the financial reports they are looking at.

"Better Boards: using the Code to review and improve your governance"

Session for trustees or whole boards to look at developmental approaches to improving your governance. The new Charity Governance Code provides a valuable framework for self-assessment and self-improvement (and it's free). We'll work through the Code to see how you and your board can use it to better develop your governance.

Monday 10th December 2018, 2.30-4.30pm (2 hours) - £15 per person (£20 for non-members).

"Technology for Trustees"

Trustees should be ensuring that technology empowers, enables and doesn't disadvantage their charity or organisation. This workshop explains how the board and trustees can lead on technology, even if they don't understand it. It covers; how to understand technology, tools, digital, internet, social media and more. Technical knowledge *not* required, but a willingness to help your organisation to understand technology is needed.
